
The aim of this workshop is to develop new perspectives on the study of criminality in late Tsarist Russia and in the early Soviet Union by focusing on two criminal figures that have not been sufficiently researched until now: the *born* and the *common* criminal. In this way, new light will be shed on both continuities and disjunctions between the pre- and the post-revolutionary periods. The workshop will discuss the potential that these trends carry for the reconceptualization of the Rus-

sian and Soviet history of criminality.

For this purpose, we intend to bring together two areas of research at the workshop that so far have been examined independently from each other: the discourse on criminality, that is, the conceptualization of criminality in a range of different disciplines and discourses - criminology, criminal anthropology, psychiatry, journalism, and literature - and the practice of punishment, that is, the laws and policies of punishment in all their aspects, from the code of law to the practice of prisons and penal camps. The workshop will assemble specialists from various disciplines (history, sociology, cultural and literary studies) in order to obtain new results through the interaction of different methodological approaches.


