- ⇒ basic questions
  - common denominator
  - definition
  - realization in language

- semantic component of morpho-syntactic categories
  - Macedonian verbal system as including 'distanced' forms showing "an action viewed as distanced in time or reality" (Lunt 1952: 91)
  - 'distance' as abstract category encompassing the functions of tense,
    taxis, aspect and mood in the Bulgarian verbal system (Fielder 1996)
- factor in interpretation
  - central role of 'distancing' for evidentiality (Joseph 2002)
  - 'distance' based on 'suspended factivity' (Topolinjska 2009)





- basis for discourse-pragmatic effects
  - point of view
  - text structuring
- factor in social interaction
  - social distance as a basic principle that influences people's use of language (Spencer-Oatey 1996)
  - distant vs. non-distant address (e.g. Betsch & Berger 2009)





- ⇒ 'distance' in linguistic analysis
  - application to different phenomena
  - reference to different domains and distinctions

# 2. 'Distance' in language and linguistics

- ⇒ 'distance' in linguistic analysis

- ⇒ no consistent terminology

The overall potential of the concept of 'distance' for the description and explanation of linguistic structures and behavior has not yet been discussed in all its facets.





# 2. 'Distance' in language and linguistics

- ⇒ 'distance' in linguistic analysis
  - distance in language

- ⇒ no consistent terminology

We need a thorough description of the basic metaphor in terms of its source domain and the possibilities of transposition to a target domain.





#### 3. Elaboration of 'distance'

- ⇒ 'distance' as metaphor (Dancygier & Vandelanotte 2009)
- source domain
  - two points separated in space
  - additional space in between
  - observer viewing both
- transfer to target domain
- ⇒ application to linguistic categories, structures, usage patterns





#### 3. Elaboration of 'distance'

- distance in language
  - form and meaning
    - morphology (e.g. verbal and nominal categories)
    - lexicon (e.g. egocentric elements)
    - syntax (e.g. embedding structures)
    - pragmatics (e.g. terms of address, imperatives)
  - interpretation, text and interaction
    - point of view
    - text and discourse structure
    - politeness
    - irony





#### 3. Elaboration of 'distance'

'Distance' emerges as relational notion that may be interpreted differently, according to the conceptual and linguistic levels it applies to.
